

Walt Odegaard Leadership Award: Christy Dauer



Christy Dauer's lifelong passion for service began at six years old and has since fueled her deep and lasting impact on North Dakota's nonprofit community. A driving force behind the North Dakota Women's Business Center (NDWBC) as its executive director, Christy has expanded programming, boosted engagement, and led the organization to record participation in coaching and training opportunities. By doing so, she has helped empower countless women to launch and grow businesses. She is also the cofounder of Power of 100, a giving initiative that has grown across the state and beyond, inspiring a culture of grassroots philanthropy. Christy's leadership extends to some of the most marginalized communities, including her transformative work in incarcerated programming that supports second chances and

pathways to economic stability. Her ability to strengthen organizations, foster collaboration, and turn vision into action has made her a pillar in the nonprofit and entrepreneurial ecosystem of North Dakota.

Partnership Building Award: Bismarck Dream Center



Since opening its doors in April 2022, the Dream Center has become a cornerstone of hope and support in the Bismarck-Mandan community, providing more than one million meals last year alone. With a mission rooted in partnership, the Dream Center opens its space free of charge to organizations that share its commitment to helping others. Each day, more than 500 guests find not only a hot meal, but access to critical services offered by partners like ND Job Service, Northland Health, Burleigh County Health, Bridging the Dental Gap, Alcoholics Anonymous, Celebrate Recovery, Memory Café, and NDSU Extension's parenting and cooking classes. Through this

model of collaborative outreach, the Dream Center has helped drive life-changing transformation for families across the region. Its leadership and innovative approach to nonprofit partnership have made a lasting impact, not only in its immediate community but across North Dakota's nonprofit sector.

Emerging Leader Award: Jakelle Hoffmann



Jakelle Hoffmann is a standout leader whose transformational style is defined by vision, collaboration and heart. As development director for Ronald McDonald House Charities of the Red River Valley, she has expanded fundraising and facility space to serve more than 900 families each year. She is a connector at her core, bringing together partners across sectors to grow community impact. Hoffman is admired not just for what she accomplishes but for the humility with which she does it, always crediting the teams and volunteers beside her.

With more than 40 years of service in the public human service system — including 28 years as director of Cass County Social Services - Sen.
