86% of North Dakotans agree the state and its residents benefit from the work done by charitable nonprofits in North Dakota.¹

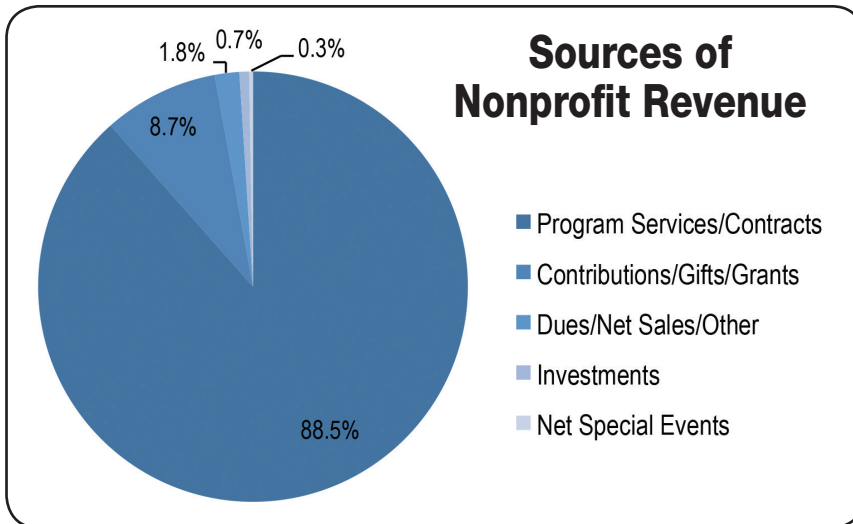
The North Dakota nonprofit sector strengthens the economy, improves



› ECONOMIC Contributors

North Dakota nonprofits strengthen the economy as employers and contributors to the state gross domestic product (GDP).

- › Employ 13% of the workforce²
- › Expend \$6.9 billion annually that contributes to the state's economy³
- › Import \$21.9 million in grants from out-of-state foundations⁴

- › Leverage volunteer power (\$404 million of service contributed⁷) to enhance professional staff and impact

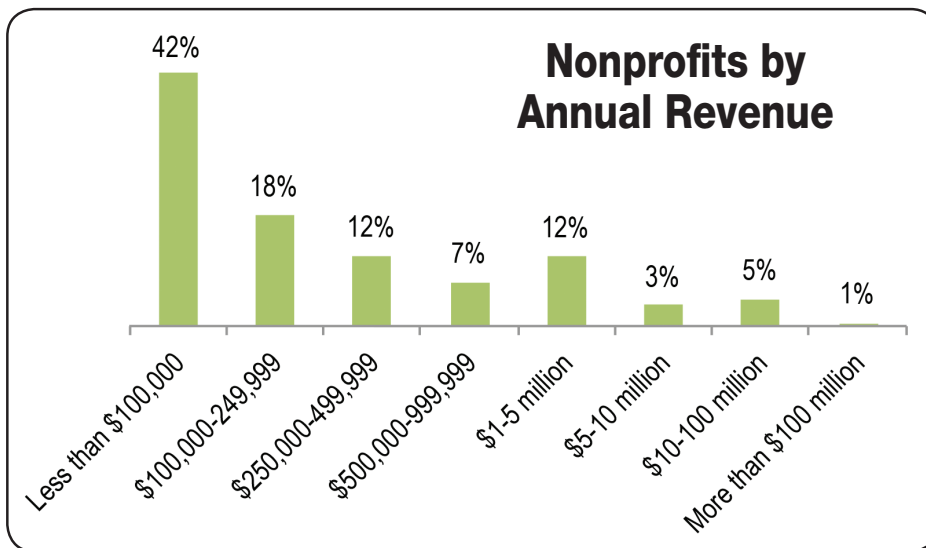
70% of North Dakotans agree state and local governments and charitable nonprofits effectively work together to provide services that enhance quality of life for North Dakotans.⁸

COMMUNITY Builders



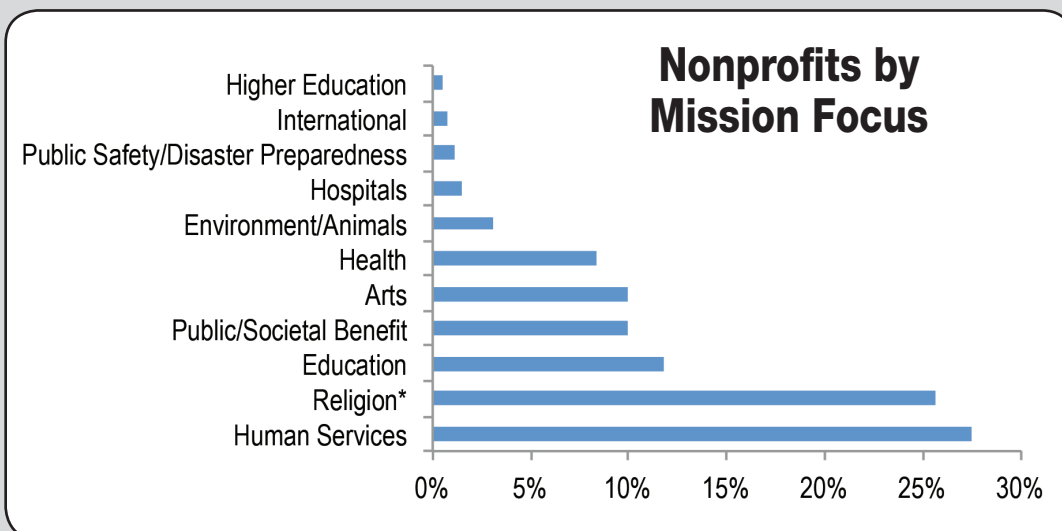
North Dakota nonprofits improve communities through critical mission work in arts and culture, education, the environment, health care, human services, religion and more.

84% of North Dakotans agree charitable nonprofits do a good job of serving the needs of people and communities in North Dakota.⁶

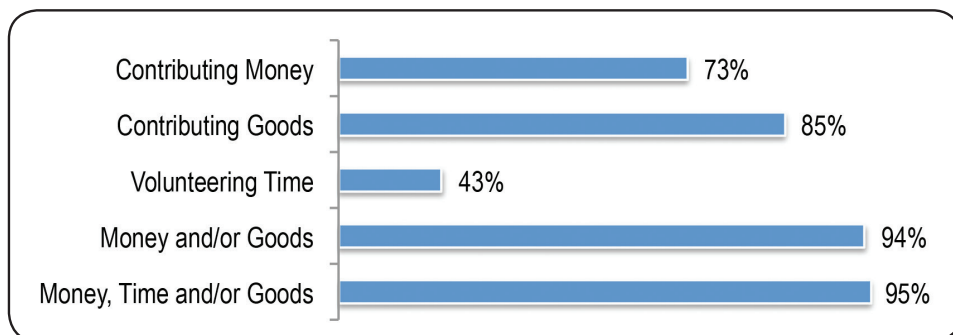

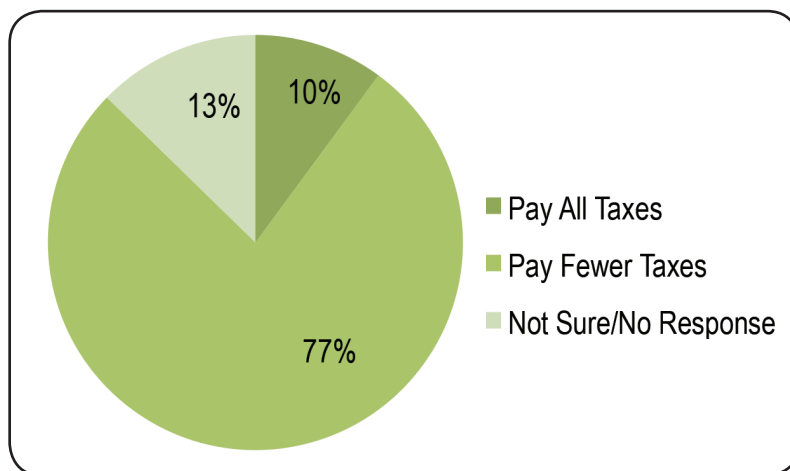
› NORTH DAKOTANS Support Nonprofits

› REGISTERED North Dakota Nonprofits

This report focuses on public charities in North Dakota. Public charities, along with private foundations, are classified by the IRS as 501(c)(3) organizations and are eligible to receive tax deductible contributions. Other nonprofits include fraternal organizations and trade associations. Not accounted for in these numbers are religious congregations, which are 501(c)(3) organizations but are not required to report to the IRS.
