## Overview:

- Coordinate and facilitate new advocate training /orientation
- Monitor and advocate within the criminal justice systems (Protection Orders and SAVIN)
- Co-plan and facilitate Legal Issues and Advanced Legal Issues training for advocates
- Facilitate a peer to peer network for advocates
- Organize and facilitate the Shelter committee meetings
- Coordination with Victim Witness Association including training, networking, etc.
- Staff the Supervised Parenting Time (Visitation) Network
- Monitor and advise of statewide issues affecting advocates/survivors
