MISSION

As the premier association, leader and voice of North Dakota's nonprofits, NDANO will strengthen communities and enhance quality of life through engaging and ensuring a strong charitable sector.

ACCOMPLISHMENTS

Advocacy -

In 2016, NDANO:

- Developed the Impact Campaign with a new key message about the impact of the state nonprofit sector and an associated toolkit to raise awareness of the sector.
- Released an updated sector report entitled Nonprofits Matter: The Impact of North Dakota's Nonprofit Sector with first-ever survey results about North Dakotans' perspectives on nonprofits.
- Held convenings in five cities across the state to distribute the sector report and provide insights into the 2017 Legislative Session.
- Informed members about state policy issues, including Legislative Management interim studies, election results and organizational session details, including the executive budget recommendations.
- Connected North Dakota nonprofits to national policy issues through membership on the public policy forum of the National Council of Nonprofits and distribution of its bi-monthly Nonprofit Advocacy Matters.

Training -

In 2016, NDANO:

- Held the annual Nonprofit Leadership Conference in Bismarck with keynote speaker Kim Klein.
- Prese nted four board development workshops around the state featuring Carter McNamara, MBA, PhD, of Authenticity Consulting.

- Hosted webinars regarding overtime changes, healthcare options and indirect cost reimbursement.
- Shared more than 75 training opportunities offered by partners (primarily with free or discounted registration fees for members), including Idealware, Nonprofits Assistance Fund and Nonprofit VOTE.
- Continued the training partnership with AFP ND Northern Plains and established a new partnership with the Minnesota Council of Nonprofits.

Resources

In 2016, NDANO:

- Published the first-ever Principles & Practices for Nonprofit Excellence in North Dakota: A Guide for Nonprofit Staff and Board Members and launched a members-only online Resource Center with a Principles and Practices "Organizational Self-Assessment Checklist."
- Published the monthly *Nonprofit Network* newsletter.
- Provided technical assistance and referrals to members and potential members.
- Posted member job openings on the website and shared via the newsletter as a free member benefit.
- Continued existing cost-saving/preferred partner programs for members: directors and officers liability insurance through Monitor Liability Managers Inc. and the Bain Agency; unemployment savings program through First Nonprofit Group; retirement plans through Mutual of America; audio and web conferencing through ReadyTalk; Giftworks™ fundraising software through Mission Research; grant database through GrantStation; website and marketing solutions through Firespring; financial services through Bremer Bank; dental and vision insurance and long-term care plans through Noridian Insurance Services; and background checks through Coeus Global.

MEMBERSHIP AND FINANCES


In 2016, NDANO:
